# -Oklahoma State Budget Cuts: What Does It Mean For Crossroads Youth & Family Services?

Most Oklahomans have watched the news and seen that as a state, we are in the midst of a budget crisis. State agencies including the Department of Corrections, the Department of Mental Health and the Department of Human Services have seen their budgets decreased by four percent in this fiscal year, which means a loss of millions of dollars used to provide services to Oklahoma residents.

Unfortunately, Crossroads Youth & Family Services has been affected by the budget cuts as well.

Our Youth Services program, which includes Counseling Services, the Emergency Youth Shelter and the Juvenile Intervention Center, received our first 3.5% budget cut for this fiscal year and could receive another 4% cut in June.

Like many other state agencies, we are working hard to minimize the impact of these cuts on the children and families we serve. However, there may be some changes to services as we navigate through this period of transition. Please be aware that these changes may cause longer waiting lists for our Counseling Services, including our group programs such as TAPP and Directions In Divorce. In addition, there might be reduced services in some areas.

We would like to thank you all



for your continued support and ask that you bear with us as we make decisions that will be continually beneficial to our clients, staff and community. Like many others, we remain optimistic and are looking forward to better days.

### An Excellent Peer Review For Youth Services!

Recently, Youth Services underwent a Peer Review by the Oklahoma Association of Youth Services. The objective of the site visit was to determine the continuation of Crossroads as a Designated Youth Service Agency. In order to continually use this status, the Peer Review Committee must find that the agency meets the standard on 11 mandatory questions and receives a score of 90% or higher on the remaining 37 questions.

Once again, Youth Services exceeded expectations. No deficiencies were noted and all 11 mandatory questions met the standards needed. In addition, the Peer Review had this to say about our program:
